Guideline on package Delivery/Drop Off:


1. All Items must be properly packaged in boxes or appropriate packaging material.
2. Contributions will be collected at the NEMA Warehouse, located at Limekiln Development, adjacent to the Antioch Baptist Church.
3. Schedule for Drop off will be from **Monday to Friday** between the hours of **9am to 3pm**.
4. Please use the acronym **GND** for Grenada and **SVG** for St Vincent and the Grenadines when labelling the package(s) to be delivered.
5. Do not seal packages until the receiving officer has verified the content, to ensure compliance with the policies of receiving state.
6. Deliverer of packages will be required to provide information to the receiving officer such as name, contact, and number of packages.
7. All contributions must be directed to the Government of the intended state. No personal or individual contributions to other parties other than the government of the intended state, will be accepted.
8. **NO** Monetary contributions will be accepted at the NEMA. Information will be provided with the banking information.
9. Please ensure that no damage or expired items are donated.
